





Multimodal Intersection Improvements







Intersection Reconfiguration

Kennedy Street/14th Street/Colorado Avenue

•Elimination of existing five-legged intersection improves safety and operation

•Colorado Avenue intersects with 14th Street, south of Kennedy Street at a new traffic signal

•Right-angle intersections reduce vehicular turning speed & improve pedestrian safety

•Bus depot approach will be signal controlled

•Bicycle lanes on 14th Street are continued through the area

Intersection Reconfiguration

Georgia Avenue/Longfellow Street/Illinois Avenue

- Relocation of Illinois Avenue
 - Reduce speed of vehicles turning left from Georgia Ave onto Illinois Ave
 - Create more storage space, from intersection, for vehicles turning left onto Illinois Ave
- Implementation of left-turn restrictions
 - From Illinois Ave onto Georgia Ave
 - For southbound vehicles on Georgia during peak periods
- New traffic signal installed at Georgia Ave and Longfellow St

Georgia Avenue/Kennedy Street


• Relocation of bus stops on Georgia Avenue to the far side of Kennedy Street to improve pedestrian safety.

• Implementation of pedestrian safety measures (lead pedestrian interval, no turn on red, left turn restrictions)












Detour Sample


PHASE 1A - KENNEDY DETOUR






